BEST PRACTICES OF THE TRIMESTER



HONDURAS

Harmonization of procedures to offer a more adequate and predictable response, as well as a better articulation between key actors for the attention of Reception & Admission returnees with protection needs.

ONE

Strengthen the capacity to identify, refer and document people with protection needs.

COSTA RICA



TWO

Immediate & persistent needs

Provide humanitarian assistance, legal orientation and integration services for refugees, displaced people, returnees and people in transit.

Inclusion of refugees and asylum seekers to social security programmes to facilitate their access to public services.

THREE

Support to host countries & communities

Strengthen the institutional response and coordination with local authorities, the civil society and private sector in host areas to promote social inclusion and socioeconomic participation.

MEXICO

Prevention of discrimination and xenophobia through communications, awareness and education initiatives relating to cultural diversity, peaceful coexistence, borders and human mobility, in host communities at the national level.

FOUR

Enhance opportunities of durable solutions

Promote public policies specifically for refugees, displaced people and returnees, while integrating them to existing programmes that encourage their self-reliance.

GUATEMALA



Engagement strategy for the private sector to promote the employability of refugees, asylum seekers and Guatemalan returnees.





Opening of the **first resource centre** at the border with Guatemala, for people with protection needs, managed in coordination with relevant authorities and Help for Progress. It is a key point to provide orientation on the asylum procedure, community initiatives and education.



Graduation of the first group of asylum seekers on Level B2 of English as a Second Language, at the **University of Belice**. This language course is provided to enhance the personal development and local integration of asyslum seekers in the country.



Descentralization of staff to three **prioritized regions** to enhance the access to the right to seek asylum for people with international protection needs in the country.





Capacity strengthening of 122 migration staff and of the refugee unit on asylum procedures, admissibility and eligibility interview techniques, identification of profiles and gender approach.



Promotion of **labour integration** of refugees and asylum seekers through the 'Employ yourself Challenge' ('Reto Empléate' in Spanish), under the auspices of the Ministry of Labour and Social Security the Women Foundation, and with the participation of twelve companies and training centres.

GUATEMALA



Provision of **work permits** for asylum seekers thanks to the entry into force of regulation No. 02-2019.



Access to **primary and secondaru education** for students who can provide proof of an unintentional lack of documentation (force majeure) and the **validation of studies** undertaken abroad, thanks to the Ministerial Agreement No. 1753-2019.



Use of **private sector platforms** and Chambers of Commerce and Exportation to raise awareness among potential employers on the local integration of refugees; provision of **seed capital** by the financial sector.

HONDURAS





Review of **protocols** to guarantee **the special protection** and **educational inclusion** in accordance with international standards of refugee and displaced children, with special focus on victims of trafficking.



Development and socialization of **tools** to plan interventions on **comprehensive attention and social inclusion**, with emphasis on databases regarding returnees and early childhood.





Instalation of the first **Interinstitutional Roundtable** on Refugees and Complementary Protection to follow-up on MIRPS commitments.



Development of the **comprehensive protection pathway of the rights of children and adolescents** based on procedures to determine their best interest, including implementation measures at the subntional level.







Provision of **work permits** for asylum seekers admitted to procedure through an Executive Decree.



Signing of a Memorandum of Understanding with the Mayor's Office, Hias and Manpower, to include both refugees and asylum seekers and the local population in the **employability programme** "Talents without Borders", to promote **peaceful coexistence**.



Agreement between the Ministry of Government and the professional training institute to grant access to **professional courses** to refugees in equal conditions as nationals.

Meeting of the "Friends of MIRPS" platform to coordinate with cooperating states and multilateral entities.

Proposal of an OAS resolution to establish and voluntary fund to finance the MIRPS (May-June)

Belize, Costa Rica, Guatemala, Honduras, Mexico and Panama adopted the San Pedro Sula Declaration in 2017, and agreed to jointly implement the Comprehensive Regional Protection and Solutions Framework (MIRPS). The MIRPS is a concrete application of the Global Compact on Refugees, which encourages regional cooperation among countries of origin, transit and destination for a greater responsability sharing in matters of prevention, protection and durable solutions.

It also entails a **participatory approach** by directly involving people with protection needs and populations impacted by violence and insecurity. On the other hand, it integrates regional and international organizations, as well as cooperating States (Argentina, Brazil, Canada, Colombia, Spain, Swizterland and Uruguay), which are committed to the **humanitarian and development agenda**.
